Small businesses to access interest free loans that will help cover operating costs during a period when revenues have been reduced due to the pandemic.

To qualify, applicants with payroll lower than \$20,000 would need:

- A business operating account at a participating financial institution
- A Canada Revenue Agency business number, and to have filed a 2018 or 2019 tax return.
- Eligible non-deferrable expenses\* between \$40,000 and \$1.5 million. Eligible non-deferrable expenses could include costs such as rent, property taxes, utilities, employment costs and insurance.

*\*Expenses will be subject to verification and audit by the Government of Canada.*

**[Canada Emergency Commercial Rent Assistance \(CECRA\)](#)** for small businesses. **(April 17)**

- The program will seek to provide loans, including forgivable loans, to commercial property owners who in turn will lower or forgo the rent of small businesses for the months of April (retroactive), May, and June.
- Implementation of the program will require a partnership between the federal government and provincial and territorial governments, which are responsible for property owner-tenant relationships.

- The program will **provide forgivable loans** to qualifying commercial property owners to cover **50 per cent of three-monthly rent payments** that are payable by eligible small business tenants who are experiencing financial hardship during April, May, and June.
- **The loans will be forgiven if the mortgaged property owner agrees to reduce the eligible small business tenants' rent by at least 75 per cent for the three corresponding months** under a rent forgiveness agreement, which will include a term not to evict the tenant while the agreement is in place. The small business tenant would cover the remainder, up to 25 per cent of the rent.

- Impacted small business tenants are **businesses paying less than \$50,000 per month in rent** and who have **temporarily ceased operations** or have **experienced at least a 70 per cent drop in pre-COVID-19 revenues**. This support will also be available to non-profit and charitable organizations.
- CECRA will be operational by mid-May, with commercial property owners lowering the rents of their small business tenant's payable for the months of April, May, retroactively, and for June.

The **Canada Mortgage & Housing Corporation (CMHC)** expects to open application process for the **CECRA** in the second half of May.

CMHC is taking staggered approach and asks property owners to register non the followings days once the application process has opened. Once registered, the portal will be available 24/7 for applicants to input the data and upload the documents. Deadline to apply August 31, 2020.

- **Monday:** Property owners who are located in Atlantic Canada, BC, Alberta and Quebec, with up to 10 tenants who are eligible for the program
- **Tuesday:** Property owners who are located in Manitoba, Saskatchewan, Ontario and the Territories, with up to 10 tenants who are eligible for the program
- **Wednesday:** All other property owners in Manitoba, Saskatchewan, Ontario and the Territories
- **Thursday:** All other property owners in Atlantic Canada, BC, Alberta and Quebec
- **Friday:** All property owners

**Canada Emergency Commercial Rent Assistance (CECRA)** program will be opened for application beginning on **May 25.**

This program will provide forgivable loans to eligible commercial property owners, who in turn will give a rent reduction of at least 75 per cent for April and May (retroactive), and June, to their small business tenants.

In addition to the timeline extension, new regulations will extend eligibility for the CEWS to the following groups:

- Partnerships that are up to 50-per-cent owned by non-eligible members;
- Indigenous government-owned corporations that are carrying on a business, as well as partnerships where the partners are Indigenous governments and eligible employers;
- Registered Canadian Amateur Athletic Associations;
- Registered Journalism Organizations; and Non-public colleges and schools, including institutions that offer specialized services, such as arts schools, driving schools, language schools or **flight schools**.

The Government also intends to propose legislative amendments to ensure that the CEWS continues to meet its objectives. These proposed amendments would:

- Provide flexibility for employers of existing employees who were not regularly employed in early 2020, such as seasonal employees;
- Ensure that the CEWS applies appropriately to corporations formed on the amalgamation of two predecessor corporations and
- Better align the treatment of trusts and corporations for the purpose of determining CEWS eligibility.

- **EI/ CPP/QPP Employer Contribution Refunds for Business using CEWS (April 8)**

Employers eligible for the CEWS are entitled to receive 100 % refund for certain employer-paid contributions to Employment Insurance, the Canada Pension Plan, the Quebec Pension Plan, and the Quebec Parental Insurance Plan.

The refund would apply to the entire amount of employer-paid contributions for furloughed employees in the period where the employer enrolled under the CEWS.

- **For businesses that do not qualify under CEWS: -**

May qualify for wage **subsidy of 10% of remuneration (up to \$1,375 per employee) and \$25,000 per employer** paid from **March 18 to before June 20, 2020.**

- **Temporary changes to Canada Summer Jobs Program (April 8)**

- An increase to the wage subsidy** – private & public sector can receive up to 100% of the provincial or territorial minimum hourly wage for each employee
- An extension to the end date** for employment to Feb 28, 2021
- Allowing employers to adapt their projects and job activities to **support essential services**
- Allowing employers to hire staff on a **part-time basis,**

**(May 11) [Larger Employer Emergency Financing Facility \(LEEFF\)](#)**

- Provide bridge financing to Canada's largest employers to keep their operations going.
- This support will not be used to resolve insolvencies or restructure firms, nor will it provide financing to companies that otherwise have the capacity to manage through the crisis.
- Companies must demonstrate how they intend to preserve employment and maintain investment activities.
- The LEEFF program will require strict limits to dividends, share buy-backs, and executive pay.
- The program will not be available to companies that have been convicted of tax evasion.
- The LEEFF financing is intended to be applicable to all eligible sectors.
- Open to all large for-profit businesses – with the exception of those in the financial sector
- Open to certain not-for-profit businesses such as airports
- Companies with annual revenues generally in the order of \$300 million or higher

**To qualify:**

- Eligible businesses must be seeking financing of \$60 million or more and have significant operations or workforce in Canada, and not be involved in active insolvency proceedings.

**Loan Guarantee for Small and Medium Sized Enterprises**

Through the BCAP, EDC is working with financial institutions to guarantee 80% new operating credit and cash flow term loans of up to \$6.25 million to small and medium sized enterprises. (SMEs)

**Co-Lending Program for Small and Medium Sized Enterprises**

Through the BCAP, [BDC](#) is working with financial institutions to co-lend term loans to SMEs for their operational cash flow requirements.

- 80% provided by BDC
- 20% provided by financial institutions
- Support is available until or before Sept 30, 2020

**BDC's Mid-Market Financing Program**

Commercial loans ranging between \$12.5 million and \$60 million to medium sized enterprises whose credit needs exceed what is already available through the BCAP and other measures.

**EDC's Mid-Market Guarantee and Financing Program**

- Bringing liquidity to companies who tend to have revenues of between \$50 million to \$300 million.
- EDC will continue to work with Canadian financial Institutions to guarantee 75% of new operating credit and cash-flow loans (ranging from \$16.75 million to a max of \$80 million)
- These expanded guarantees are available to exporters, international investors and businesses that sell their products or services within Canada.

The WCB board of directors has approved and authorized further relief for employers who fund the WCB by returning approximately \$37 million in surplus funds.

In May, eligible employers will receive a credit to their account based on 20% of their 2019 premium.

A new or existing business interested in getting established or expanding in Manitoba may apply to the program if:

- The business is prepared to make a minimum capital investment of \$10 million to specific property, which will be designated for tax increment financing benefits;
- A minimum of 65% of total projects costs are from private sources; and
- There is demonstrable potential to create and/ or maintain jobs in Manitoba, or the new business activity will have a substantial and measurable net economic benefit to the province.

**(NEW May 20)** The Manitoba government is providing \$10 million in grants to support 344 projects for community development as part of restarting the provincial economy during the COVID-19 pandemic.

- Cruise ships with overnight accommodations allowed to carry more than 100 persons are prohibited from operating in Canadian waters until October 31, 2020.
- As of July 1, 2020, all other passenger vessels must follow provincial, territorial, local and regional health authority requirements for timelines and processes to resume operations.
- Passenger vessels with the capacity to carry more than 12 persons continue to be prohibited from entering Arctic coastal waters (including Nunatsiavut, Nunavik and the Labrador Coast) until October 31, 2020.

#### **Changes to travel restrictions for immediate family members of Canadian citizens and permanent residents**

**As of June 8, 2020 23:59 EDT**, foreign nationals who are immediate family of members of Canadian citizens and permanent residents, and who do not have COVID-19 or exhibit any signs or symptoms of COVID-19, or do not have reason to believe they have COVID-19, will be exempt from the prohibition of entry to Canada if entering to be with an immediately family member for a period of at least 15 days.

Foreign nationals who are admitted into Canada pursuant to this exemption **must** [quarantine](#) for 14 days.

**Manitoba Protection Plan** (The following protections are in place for the next six months - until Oct 1)

- Manitoba Hydro, Centra Gas and Manitoba Public Insurance (MPI) do **not charge interest or penalties** in the event Manitobans are unable to pay at this time.
- Instructing MPI to relax ordinary practices on policy renewals and collections
- Support Workers Compensation Board (WCB) to do the same and asking WCB to extend relief from penalties for late payments
- Direct Manitoba Hydro and Centra Gas to NOT disconnect customer during these times
- Working with Municipalities DO NOT charge interest on provincial education taxes and school division fees

Deferring provincial income tax and corporate tax filing deadlines and payments to coincide with the current revised federal referral of income tax to Aug 31, and willing to extend these deferrals until Oct 1 (should the federal government agree).

Accelerating removal of \$75 million of annual PST from residential and business properties, effective July 1.

**Manitoba COVID-19 Procurement Fund (\$400 million)** will support outbreak planning, prevention and mitigation efforts, and allow the province to secure the supplies and resources needed to deliver the best care possible for Manitoba patients.

Funds are being used for purposes such as:

- purchasing significant amounts of essential medical supplies and equipment, including personal protective equipment;
- developing hotel capacity for those requiring isolation;
- preparing for large-scale low acuity medical overflow for hospitals;
- supporting the local, made-in-Manitoba production of gowns, scrubs, gloves and other medical equipment including an RFP to award \$15 million of production to Manitoba-designed reusable silicone N95 masks;
- providing training and grants to child-care experts to become entrepreneurs by opening their own small-scale daycares;
- establishing a COVID-19 research fund through Research Manitoba;
- providing a new digital online service for mental health support;
- creating <https://helpnextdoormb.ca/> to link Manitobans needing help with volunteers;
- engaging local call centre, 24-7 Intouch, to contact Manitobans to drive awareness of government support programs to small businesses, charities and not-for-profits; and
- opening multiple provincewide testing sites to bolster the response to this health crisis.
